## **ELECTION RESOLUTION FOR 2025 REGULAR DISTRICT ELECTION**

## **RESOLUTION NO. 2025**

## §32-1-804-, §1-13-5, C.R.S.

WHEREAS, the terms of office of two Directors shall expire after their successors are elected at the regular special District election to be held on May 2, 2025 ("Election") and take office; and

WHEREAS, in accordance with the provision of the Special District Act ("Act") and the Colorado Local Government Code ("Code"), the election must be conducted to elect 3 Directors to serve for a term of <u>three (3)</u> years; and

**NOW, THEREFORE,** be it resolved by the Board of Directors of the Alpha Rockridge Metropolitan District in the County of Archuleta, State of Colorado that;

- The election shall be conducted as a mail ballot election in accordance with all relevant provisions of the Code. The Designated Election Official shall develop a Plan for conducting the mail ballot Election, which will be made available to the public. There shall be no election precinct or polling place. All mail ballots shall be returned to the designated Election Official's mailing address.
- 2. The Board of Directors hereby designates <u>Gary Lansdale</u> as the Designated Election Official for the conduct of the election on behalf of the District, who is hereby authorized and directed to proceed with any action necessary or appropriate to effectuate the provision of this Resolution and Act, Code, or other applicable laws. The Election shall be conducted in accordance with the Act, Code, and applicable laws. Among other matters, the Designated Election Official shall publish the call for nominations, appoint election judges as necessary, appoint the Canvass Board, arrange for the required notices of election, and printing of ballots, and direct that all other appropriate actions be accomplished.
- 3. Self-Nomination and Acceptance forms are available at the Designated Election Official's mailing address or at the Alpha Rockridge official web site shown below. All candidates must file a Self-Nomination and Acceptance form with the Designated Election Official no earlier than January 1, 2023, nor received no later than Thursday, February 27, 2025.
- 4. If the only matter before the electors is the election of Directors of the District and if, at the close of business on February 27, 2025, there are not more candidates than offices to be filled at the Election, including candidates timely filing affidavits of intent no later than February 27,2025, the Designated Election Official shall cancel the Election and declare the candidates elected. Notice of such cancellation shall be published and posted in accordance with the Code. The Notice and this resolution, signed by the Board Chair, shall be filed with the Division of Local Government.
- 5. If the only matter before the electors is the election of Directors of the District and if at the close of business on March 20, 2025, there are not more candidates than offices to be filled at the Election, including candidates timely filing affidavits of intent no later than March 20, 2025, the Designated Election Official shall cancel the Election and declare the candidates elected. Notice of such

cancellation shall be published and posted in accordance with the Code. The Notice and this resolution, signed by the Board Chair, shall be filed with the Division of Local Government.

- 6. If any part or provision of this Resolution is adjudged to be unenforceable or invalid, such judgement shall not affect, impair or invalidate the remaining provision of this Resolution, it being the Board's intention that the various provisions hereof are severable.
- 7. Any and all actions previously taken by the Designated Election Official or the Secretary of the Board of Directors or any other person's action on their behalf pursuant to the Act, the Code or other applicable laws, are hereby ratified and confirmed.
- 8. All acts, order, and resolutions, or parts thereof, of the Board which are inconsistent or in conflict with this Resolution are here by repealed to the extent only of such inconsistency or conflict.
- 9. The provisions of this Resolution shall take effect immediately.
